AN ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD AMENDING ORDINANCE 2015-24 AN ORDINANCE APPROVING THE APPLICATION FOR TAX ABATEMENT SUBMITTED BY DACK HOLDINGS, LLC AND AUTHORIZING THE TOWNSHIP OF WEST DEPTFORD THROUGH ITS PROPER OFFICERS TO ENTER INTO A WRITTEN AGREEMENT WITH THE APPLICANT FOR THE ABATEMENT OF LOCAL REAL ESTATE PROPERTY TAXES ON BLOCK 354.04, LOTS 7 AND 8 ALSO KNOWN AS 1395 AND 1351 IMPERIAL WAY TO PROPERLY IDENTIFY THE CORRECT BLOCK NUMBER AS BLOCK 347.04

WHEREAS, the Township of West Deptford had adopted Ordinance #2015-24 on November 16, 2015 approving the tax abatement for DACK Holdings, LLC; and

WHEREAS, it has been determined that an incorrect block number (i.e., Block 354.04) had been used to identify the property in the Ordinance; and

WHEREAS, the purpose of this Ordinance is to amend the previously adopted Ordinance to now identify the correct block number (i.e, Block 347.04) for the property.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of West Deptford, in the County of Gloucester, and State of New Jersey, that Ordinance #2015-24 adopted on November 16, 2015 be and is hereby amended to identify the correct block number for the subject property as Block 347.04.

BE IT FURTHER ORDAINED this ordinance shall take effect immediately upon final passage and publication as required by law.
