RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD TO APPROVE PARTICIPATION WITH THE STATE OF NEW JERSEY IN A SAFE AND SECURE COMMUNITIES PROGRAM ADMINISTERED BY THE DEPARTMENT OF LAW AND PUBLIC SAFETY

WHEREAS, the Township Committee of the Township of West Deptford wishes to apply for funding for a project under the Safe and Secure Communities Program (Grant Number P-7074-17) in the amount of \$235,862.90; and

WHEREAS, the Township has reviewed the accompanying application and has approved said request; and

WHEREAS, the project is a joint effort between the Department of Law and Public Safety and the Township of West Deptford for the purpose of providing funding for additional law enforcement personnel to address crime in a focused community-oriented manner, which is more specifically described in the application.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, Gloucester County, New Jersey, as follows:

1. As a matter of public policy West Deptford Township Police Department wishes to participate to the fullest extent possible with the Department of Law and Public Safety.
2. The Attorney General will receive funds on behalf of the applicant.
3. The Division of Criminal Justice shall be responsible for the receipt and review of the applications for said funds.
4. The Mayor and Township Clerk are authorized to sign or issue and appropriate documentation to give effect to the within resolution.
5. The Division of Criminal Justice shall initiate allocations to each applicant as authorized.





GOAL OF THE SAFE AND SECURE COMMUNITIES PROGRAM:

The Safe and Secure Communities Program is designed to provide municipalities with funding for additional law enforcement personnel to address crime in a focused community-oriented manner.

1. To what specific target areas and/or specific assignments will the Safe and Secure funded officers be assigned:

Officer James Greco is assigned to the Patrol Division of the West Deptford Twp Police Department. His patrol duties include but are not limited to investigating and arresting subjects involved in narcotics, burglaries, robberies, thefts, crimes against persons, damage to property along with protecting and serving the citizens of West Deptford Township. Ptlm. Greco is a member of the D.A.R.E. program, Neighborhood Watch Program, and is involved with numerous crime prevention and community based programs. Ptlm Greco is active in presenting our residents with various tools and awareness in regards to crime prevention. Ptlm. Greco is also involved in all community activities that are related to the West Deptford Police Department such as, National Night Out, Family Fun Day, Spooky Palooza, Junior Police Academy, Fill a Cruiser campaign (xmas toys), Food Drive, etc...

Officer David Jiles is a member of the Special Operations Division and is assigned as the School Resource Officer. His primary responsibility is to maintain the safety and security of Red Bank Elementary School, Oakview Elementary School, Greenfields Elementary School, West Deptford Middle School and the West Deptford High School. SRO Jiles rotates through the schools and maintains their security and continually improves the safety of the infrastructure and the safety of the children.

Officer Jiles continues to have an outstanding relationship with the school administration, teachers, and students. The students rely on him as a mentor and role model in our community. They have complete trust in SRO Jiles and commonly provide intelligence to him, which improves school safety and assists in deterring, preventing and solving crime. He continues to handle any law enforcement related activities within the school system.

SRO Jiles is a L.E.A.D's (formerly D.A.R.E.) instructor, which leads to further interactions with the students. The L.E.A.D's program is critical in establishing relationships with the students and teaching them the importance of drug and alcohol resistance. He is the liaison for the School Safety Patrol Program and Safety Town Programs which teach, educate children on general safety and encourages leadership. All of the aforementioned programs have a critical impact on the prevention of crime.

SRO Jiles is assigned as our Juvenile Officer/Liaison and is responsible for a majority of investigations involving juvenile suspects. He continues to be involved and provide support and resources to juvenile victims and witnesses. When he is not involved in juvenile and SRO matters, he is involved in matters that increase the quality of life to our residents and prevents crime.

2. List SPECIFIC problems and proposed strategies that the Safe and Secure Communities Grant funded officers will employ to reduce crime:

One of our common problems in our community are car and house burglaries. We have found that it is common that the residents observe suspicious persons and activity but fail to call the police and are reluctant to get involved. To help increase the crime awareness and increase the assistance from the public, our department has established a Special Operations Division, which includes Community Policing. Since the establishment of our Special Operations Division, our department has become more involved with the community and more specifically, the Town Watch Program. Each neighborhood in our town has established a Town Watch Program.

The Town Watch program has had great success and has led to the identification of potential or active criminal violators.

Ptlm. Greco and SRO Jiles are the two contact persons for our Neighborhood Watch program. They are both involved with our community through this program and frequently meet with the members and attend monthly meetings. On a daily basis, they interact with the program members and assist them in any way they can. They have given numerous crime prevention presentations to the Neighborhood Watch Program members such as reporting suspicious persons/activity, how to properly secure your house and vehicles, safety tips in regards to banking (credit cards/ATM etc.), phone scams, computer related crimes, gypsy related activities, safety tips around the holidays, environmental awareness, etc...

Another constant, is the police department's concern with juvenile drug use. Officer Jiles is assigned as our School Resource Officer and is an active member of our D.A.R.E. program, neighborhood watch program (see above), and all community activities. Officer Jiles has constant interaction with the students through his D.A.R.E. instruction and as the S.R.O. He also assists the counselors at the schools in identifying and targeting at-risk children within our district. Officer Jiles acts as a mentor to these children and attempts to provide direction children prior to their involvement in crime and drug use. Officer Jiles and the Special Operations Commander are in the process of developing a drug awareness program at the high school to educate and prevent future drug use and involvement in criminal activities.
