- Performer to provide production (PA system, lights, tech(s))
 - Buyer to provide stage area and adequate power
 - In the event of cancellation due to inclement weather, performers/production crews should be notified to later than 3 hours prior to scheduled event. Should performers/production crews arrive on-site, performer shall be entitled to full Scheduled Fee amount
1. The facsimile and/or email transmission of a signed copy of this agreement, any counter offer, addendum or amendment to the other party/representative, followed by faxed or computer generated signed receipt, shall constitute delivery of the signed document.
 2. It is understood by all parties that any and all return engagements by the performer(s) at place of engagement will be secured and negotiated solely by Anderson Entertainment Management, Inc. for a period of no less than 2 years from the last scheduled engagement.
 3. Representative acknowledges and agrees that representative is fully authorized to execute the terms and conditions put forth in this agreement on the venue(s) behalf.
 4. All parties agree that Performer(s) are contracting as a self-employed independent contractor and Anderson Entertainment Management, Inc. is in no way responsible for any and all withholding taxes, workman's compensation, social security contributions, liability insurance etc. Furthermore, Anderson Entertainment Management, Inc. assumes no liability for any wrongful acts loss or damage to persons or property that Performer(s) may cause.
 5. Anderson Entertainment Management, Inc. is party to this agreement solely for the purpose of securing its interest as a licensed and bonded booking agency and shall not be held responsible for any breach of contract on the part of the Venue and/or Performer(s). Venue and Performer(s) agree to save Anderson Entertainment Management, Inc. harmless in the event any such breach of contract occurs.
 6. If any of the terms and conditions put forth in this agreement are determined to be void or unenforceable, the remaining terms and conditions hereof shall remain in full force. Representative acknowledges and confirms that they have read and approved of the terms and conditions set forth in this agreement.
 7. This agreement may under no circumstances be canceled except for: acts of God, accident, strike, sickness, breakdown of transportation, national emergency, etc., except for events beyond the control of the Agency.
