**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AN APPLICATION FOR GLOUCESTER COUNTY UTILITIES AUTHORITY ENDORSEMENT FOR NJDEP TREATMENT WORKS APPROVAL-RECONSTRUCTION OF PUMP STATION NUMBER 4 AND PUMP STATION NUMBER 6**

**WHEREAS**, Pump Station Number 4 and Pump Station Number 6 in the Township of West Deptford are in need of rehabilitation and upgrade; and

**WHEREAS**, the Township desires to rehabilitate and upgrade Pump Station Number 4 and Pump Station Number 6; and

**WHEREAS**, the rehabilitation and upgrades will include replacement of the pumps and motors, addition of emergency standby generators, fencing and other necessary improvements; and

**WHEREAS**, the Township, through its Engineers, has developed a plan for the rehabilitation and upgrade of Pump Station Number 4 and Pump Station Number 6; and

**WHEREAS**, this plan includes submitting and application to the NJDEP Division of Water Quality for a Treatment Works Approval Permit; and

**WHEREAS**, a prerequisite of submitting the application for the Treatment Works Approval Permit to the NJDEP is applying for and obtaining the endorsement of the Gloucester County Utilities Authority for NJDEP Treatment Works Approval-Reconstruction of Pump Station Number 4 and Pump Station Number 6; and

**WHEREAS**, the application for the endorsement of the Gloucester County Utilities Authority has been prepared by the Township Engineer and reviewed by the Township Committee.




2. That the Mayor and/or Township Administrator be and is hereby authorized to execute any and all documents related to this approval.
