**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD APPROVING MARIO'S
AUTO & TRUCK REPAIR, L.L.C. AS A TOW OPERATOR FOR THE TOWNSHIP OF
WEST DEPTFORD**

WHEREAS, Mario's Auto & Truck Repair, L.L.C. ("Mario's") submitted an application dated May 4, 2015 to be placed on the towing rotation list of the Township of West Deptford pursuant to the policies and procedures of the Township's Towing Chapter 152; and

WHEREAS, an initial inspection of the property by the Chief of Police determined that Mario's storage yard did not have a secure structure to store vehicles if requested by the West Deptford Township Police Department; and

WHEREAS, the Chief of Police was advised that Mario's was in the process of building a structure to house vehicles which would be secured and locked; and

WHEREAS, Mario's application was initially rejected for not having a secure structure and, thereby, not placed on the towing rotation list; and

WHEREAS, the Chief of Police has recently re-inspected the property and determined that Mario's now has a secure structure that can house vehicles and is secure from outside obstacles and able to be locked; and

WHEREAS, Mario's Auto & Truck Repair, L.L.C. application and storage yard have been determined by the Chief of Police to satisfy all of the appropriate conditions necessary for approval as a tow operator for the Township of West Deptford in accordance with Chapter 152; and

WHEREAS, the Township Administrator is in agreement to approve Mario's Auto & Truck Repair, L.L.C. as an approved tow operator for the Township of West Deptford; and

WHEREAS, the approval shall take effect on March 3, 2016 and shall continue to June 30, 2018, at which time tow operators may re-apply to be placed on the towing rotation list of the

Township of West Deptford in accordance with Chapter 152.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That the Township Committee does hereby approve Mario's Auto & Truck Repair, L.L.C. of Bridgeport, New Jersey, as an authorized and approved tow operator for the Township of West Deptford for the period of March 4, 2016 to June 30, 2018 pursuant to Chapter 152 of the Township of West Deptford Code Book.

2. That the Mayor and/or Township Administrator be and is hereby authorized to execute any and all documents related to this approval.
