**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD FOR THE  
REMOVAL OF WATER AND SEWER CHARGES**

**WHEREAS**, there exists an overcharge/undercharge on the books of the Water and Sewer Department of the Township of West Deptford which should be removed; and

**WHEREAS**, the Township and its professionals investigated this matter in an attempt to collect said charges; and

**WHEREAS**, the Township has reviewed its records, or lack thereof; and

**WHEREAS**, the Township has consulted with its professionals and due to the lack of records and improper management of records in prior years, the Township would be unable to prove the amount of the charges owed by the past and present account holders; and

**WHEREAS**, it has been determined by the Township Committee that amnesty is the best course of action; and

**WHEREAS**, this course of action is most fair to the account holders as well as the Township as a whole from a litigation and cost standpoint; and

**WHEREAS**, the 2014 Township Solicitor and Auditor agree with this course of action; and

**WHEREAS**, the Treasurer recommends the removal of charges; and

**WHEREAS**, the removal of charges requires the authorization of the governing body;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester, State of New Jersey, that the removal of the following charges be approved and the Treasurer is hereby authorized and directed to affect the same:


