**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING A CONTRACT BETWEEN THE TOWNSHIP
OF WEST DEPTFORD AND BOTTO'S ITALIAN LINE RESTAURANT
TO PROVIDE CONCESSION SERVICES WITH ALCOHOLIC BEVERAGES
FOR THE 2016 RIVERWINDS STREETFEST CONCERT SERIES**

WHEREAS, there exists a need in the Township of West Deptford ("Township") to provide concession services ("Services") with alcoholic beverages for the RiverWinds Streetfest Concert Series located at the amphitheater adjacent to the RiverWinds Community Center in the Township of West Deptford; and

WHEREAS, after bid proposals were received and opened on May 11, 2016, Botto's Italian Line Restaurant ("Botto's") of Swedesboro, New Jersey was determined to be the only responsible bidder; and

WHEREAS, Botto's has submitted all the required information per the bid specifications to provide the Services; and

WHEREAS, the Purchasing Agent has reviewed the bid proposal submitted and finds that the bid documents meet the specifications; and

WHEREAS, the specifications for the Services are incorporated by reference herein; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 18th day of May, 2016, that a contract be entered into, in the form attached hereto and made a part hereof, with Botto's Italian Line Restaurant for the provision of concession services with alcoholic beverages for the 2016 RiverWinds Street Fest Concert Series at the RiverWinds Community Center for the dates

specified in the bid documents between June 2016 and August 2016; and

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.


