**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING THE PLACE-TO-PLACE TRANSFER
(EXPANSION OF PREMISES)
OF PLENARY RETAIL CONSUMPTION LICENSE

WHEREAS, an application has been filed by JNB Riverwinds, Inc. for a place-to-place transfer (i.e. expansion of premises) of Plenary Retail Consumption License number 0820-33-006-010, for purposes of expanding the premises under license wherein the sale, service and storage of alcoholic beverages are authorized; and


