**RESOLUTION AWARDING A CONTRACT FOR CLEMENT DRIVE WATER
MAIN INSTALLATION, SERVICE CONNECTION AND WELL SEALING
PROJECT TO NERI CONSTRUCTION**

WHEREAS, the Township of West Deptford solicited, received and opened sealed bids on May 11, 2016 at 10:00 am prevailing time for the Clement Drive Water Main Installation, Service Connection and Well Sealing project (the Project); and

WHEREAS, said bids were duly advertised in accordance with Local Public Contracts Law N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, West Deptford Township has entered into a contract (ICU-RW1-15) with the New Jersey Department of Environmental Protection, Site Remediation Program to provide funding to West Deptford Township to complete the Project; and

WHEREAS, West Deptford Township has secured temporary financing in the amount of \$350,000 to pre-fund the Project cost; and

WHEREAS, all bid results and recommendations are on file in the Office of the Township Purchasing Agent as required by Law; and

WHEREAS, submitted bids were as follows:

BIDDER'S NAME	Total Bid Price
Neri Construction	\$ 120,715.00
Klein Construction	\$ 129,430.00
South State Construction	\$ 158,142.00

WHEREAS, Neri Construction was the lowest, responsive and responsible bidder for the base bid; and

WHEREAS, Neri Construction complied with the bid specifications in all respects; and

WHEREAS, in accordance with N.J.A.C. 5:30-5.4, funds shall be encumbered for this contract by the West Deptford Township Chief Financial Officer.

NOW, THEREFORE, BE IT RESOLVED by the West Deptford Township Committee as follows:

1. That the West Deptford Township Committee does hereby award a contract based upon the unit prices and extended price provided in their bid submission for the base contract in a total amount not to exceed \$ 120,715.00 to Neri Construction for the Clement Drive Water Main Installation, Service Connection and Well Sealing project, which shall be completed in full accordance with the terms and conditions of said contract, subject to review and approval by the Township Solicitor.
2. The Mayor and the Township Clerk shall be authorized to execute said contract upon compliance by the bidder with bond and insurance requirements of the specifications.
