**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING THE AWARD OF A BID FOR STERLING ROAD ROADWAY IMPROVEMENTS
TO ARAWAK PAVING COMPANY**

WHEREAS, the Township of West Deptford has received a grant from the New Jersey Department of Transportation (NJDOT) for CY 2015 in the amount of \$170,000; and

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the Sterling Road Roadway Improvements Project; and

WHEREAS, the Township has solicited and received bids for the Sterling Road Roadway Improvements Project; and

WHEREAS, the Township received the following bid proposals:

Arawak Paving Co. - \$138,900.00
American Asphalt - \$138,935.00
Landberg Construction - \$149,136.42
R.E. Pierson Construction - \$170,360.42
Bogey's Trucking and Paving - \$181,374.00

WHEREAS, Arawak Paving Co. (Arawak) submitted the lowest responsible and responsive bid proposal for the Sterling Road Roadway Improvements Project for a lump sum bid amount not to exceed \$138,900.00; and

WHEREAS, T&M Associates has provided a Letter of Recommendation for Contract Award to the Township dated June 29, 2016 recommending that the Township award the contract to Arawak Paving Co. (Arawak); and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original said Certification is attached to the original of this Resolution and shall be kept on file at the Township Clerk's office; and,

WHEREAS, in light of certain state budget issues which are unresolved at this time, the Governor's office has indicated their intention to curtail funding for projects funded with the New Jersey Department of Transportation- Transportation Trust Funds; and

WHEREAS, the Township Engineer has solicited information from the NJDOT in regards to projects already awarded and those about to be awarded involving CY 2015 grant funding and has received a response indicating that staff is awaiting further direction from management regarding this matter; and

WHEREAS, the Township believes it to be prudent to proceed to award said contract conditioned upon approval and authorization from the NJDOT so that certain grant funding deadlines can be met;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 6th day of July, 2016, that a contract be and is hereby awarded to Arawak Paving Co. (Arawak) of Hammonton, New Jersey in the total bid amount not to exceed \$138,900.00 for the Sterling Road Roadway Improvements Project, subject to all terms and conditions contained in the bid package.

BE IT FURTHER RESOLVED that the award of this contract is conditioned upon the NJDOT authorizing the use of the CY 2015 grant funds for said project.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.


