**RESOLUTION APPOINTING A QUALIFIED PURCHASING AGENT AND ESTABLISHING A BID THRESHOLD FOR WEST DEPTFORD TOWNSHIP, GLOUCESTER COUNTY, NEW JERSEY**

**WHEREAS**, N.J.A.C. 5:34-5 et seq. establishes the criteria for qualifying a Qualified Purchasing Agent; and

**WHEREAS**, N.J.S.A. 40A:11-3 provides limits on the bid threshold when a Qualified Purchasing Agent is appointed and grants the authorization to negotiate and award such contracts below the bid threshold; and

**WHEREAS**, Barbara Lamplugh, Purchasing Agent possesses the designation of Qualified Purchasing Agent as issued by the Director of the Division of Local Government Services, in accordance with N.J.A.C. 5:34-5 et seq.;

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of West Deptford, Gloucester County, State of New Jersey hereby appoints Barbara Lamplugh, as the Qualified Purchasing Agent to exercise the duties of a purchasing agent pursuant to N.J.S.A. 40A:11-2(30), with specific relevance to the authority, responsibility and accountability of the purchasing activity of the Township of West Deptford; and

**BE IT FURTHER RESOLVED**, that the Township Committee of West Deptford has determined that the Qualified Purchasing Agent shall have the authority to award contracts for good and services with an anticipated value not more than \$40,000 in accordance with the Local Public Contracts Law N.J.S.A. 40A:11, except for the Fair and Open contracts which have a bid threshold of \$17,500; and

**BE IT FURTHER RESOLVED** that in accordance with N.J.A.C. 5:34-5.2, that the Mayor and Clerk of West Deptford Township are hereby authorized to and directed to forward a certified copy of this resolution and a copy of Barbara Lamplugh's certification to the Director of the Division of Local Government Services.


