RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF A SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE MANTUA TOWNSHIP FIRE DISTRICT FOR MAINTENANCE OF VEHICLES OWNED AND OPERATED BY THE TOWNSHIP OF WEST DEPTFORD

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") owns three construction fleet vehicles; and

WHEREAS, the Township desires to have emergency lights installed on the three construction fleet vehicles; and

WHEREAS, the Township has solicited for and received quotes for the installation of emergency lights on the construction fleet vehicles; and

WHEREAS, the Mantua Township Fire District (hereinafter referred to as "Mantua Fire District") has submitted the lowest quote in the amount of \$3,398.84 for the installation of emergency lights on the construction fleet vehicles pursuant to the attached quote dated February 28, 2017; and

WHEREAS, the Township desires to enter into a Shared Services Agreement with the Mantua Fire District for the installation of emergency lights on the construction fleet vehicles and for other future maintenance on vehicles owned and operated by the Township of West Deptford during the term of this Shared Services Agreement; and

WHEREAS, a Shared Services Agreement has been prepared pursuant to the mutual understanding of the Parties.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 5th day of April, 2017 that the Township of West Deptford does hereby authorize the execution of a Shared Services Agreement between the Township of West Deptford and the Mantua Township Fire District for the installation of emergency lights on the construction fleet vehicles owned by the Township of West

Deptford for the amount of \$3,398.84 pursuant to the attached quote dated February 28, 2017 and for other future maintenance of vehicles owned and operated by the Township of West Deptford during the term of this Shared Services Agreement; and

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting this matter.





SHARED SERVICES AGREEMENT BETWEEN THE MANTUA FIRE DISTRICT NO. 1 AND THE TOWNSHIP OF WEST DEPTFORD FOR MAINTENANCE OF VEHICLES OWNED AND OPERATED BY THE TOWNSHIP OF WEST DEPTFORD

THIS AGREEMENT, made this 5th day of April, 2017 by and between:

MANTUA FIRE DISTRICT NO.1, in the Township of Mantua, County of Gloucester and State of New Jersey, (Hereinafter referred to as the "District") and the TOWNSHIP of WEST DEPTFORD, County of Gloucester and State of New Jersey, (Hereinafter referred to as the "Township").

WHEREAS, Township deems it necessary to secure assistance in providing services concerning accessory purchase and installation and vehicle maintenance of owned and operated by the Township; and

WHEREAS, the District through its Mechanic is able to provide these services to the Township; and

WHEREAS, the District and Township have reached an agreement relative to the providing of these services and the terms and conditions relative to same; and

WHEREAS, it is in the best interest of the public that such an agreement be entered into

WHEREAS, N.J.S.A. 40A:65-1 et seq. ("Shared Services Law") specifically authorizes local government units to enter into shared services agreements; and

WHEREAS, the parties to this Shared Services Agreement agree that their mutual public purposes and their best interests will be promoted by the execution and delivery of this Agreement pursuant to the powers conferred by the Shared Services Law;

NOW, THEREFORE, in consideration of the foregoing recitations and the mutual covenants and promises hereinafter contained, the parties hereby agree as follows:

- (1) The District, by means of its Mechanic, shall provide on behalf of the Township the necessary and appropriate vehicle maintenance for the Township of West Deptford and shall agree upon the specific procedures to enact the providing of these services.
- (2) The District shall provide written estimates to the Township for accessories to be purchased, in advance of purchase, and will invoice the Township the direct cost.
- (3) The District shall provide an estimated number of hours to install accessories in advance of undertaking any work and will invoice the Township at the rate of \$40 per hour.

- (4) The District shall receive payment from the Township of \$40.00 per hour for the providing of these services. The Township shall submit a voucher for the District to receive payment.
- (5) This agreement shall be deemed effective after approval by Resolution by each of the entities and shall have a term of April 5, 2017 to December 31, 2017. It shall be automatically renewable, for a period of three (3) years (through December 31, 2019) and/or continued during its designated term unless terminated by either party upon 60 days prior written notice to all parties.
- (6) The terms and conditions set forth represent the entirety of the agreement between the parties.

IN WITNESS WHEREOF each party has caused its authorized officials to sign and seal this Agreement the date first hereinbefore set forth.


