- WHEREAS, the Township Administrator of the Township of West Deptford currently serves at the pleasure of the governing body; and
- **WHEREAS,** the Township Administrator has been appointed to various Township positions and boards; and
- WHEREAS, N.J.S.A. 40A:9-138 and Township Code § 5-2(B) provide for the removal of a Township Administrator on a 2/3 vote of the governing body; and
- WHEREAS, N.J.S.A. 40A:9-138 and Township Code § 5-2(B) permit the governing body to make such removal effective immediately, provided that the Township Administrator shall be paid her salary for the next three (3) calendar months; and
- WHEREAS, the governing body desires to remove the Township Administrator from office, effective immediately; and
- **WHEREAS,** the governing body also desires to remove the Township Administrator from all other appointed positions and boards she currently holds, effective immediately;
- **NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey, pursuant to N.J.S.A. 40A:9-138 and Township Code § 5-2(B), that Deborah Turner-Fox shall be, and hereby is, removed from the position of Township Administrator, effective immediately.
- **BE IT FURTHER RESOLVED,** by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey, that Deborah Turner-Fox shall be, and hereby is, removed from the positions of Fund Commissioner (Resolution 2017-18), Public Agency Compliance Office (Resolution 2017-23), Executive Director of West Deptford Redevelopment Entity (Resolution 2017-24), and Member of the Green Team (Resolution 2017-46).
- **BE IT FURTHER RESOLVED,** by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey, pursuant to N.J.S.A. 40A:9-138 and Township Code § 5-2(B), that Deborah Turner-Fox shall be paid her regular salary for three (3) calendar months from the adoption of this Resolution, along with any other unpaid salary or benefits she is now due from the Township of West Deptford.
