**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 17th day of May, 2017, that a contract be and is hereby awarded to SharpLink Staffing LLC of Pitman, New Jersey in the amount as provided in the bid proposal submitted to the Township, for temporary labor services for the Township of West Deptford, subject to all terms and conditions contained in the bid package.

**BE IT FURTHER RESOLVED** that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.


