**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF
AMENDMENT NO. 1 TO THE INTERLOCAL SERVICES AGREEMENT BETWEEN THE
TOWNSHIP OF WEST DEPTFORD AND THE WEST DEPTFORD BOARD OF EDUCATION
FOR INFORMATION TECHNOLOGY EQUIPMENT AND SUPPORT SERVICES**

WHEREAS, on or about December 7, 2016, the Township of West Deptford (hereinafter referred to as "Township") and the West Deptford Board of Education (hereinafter referred to as the "WDBOE) (collectively referred to as the "Parties") entered into an Interlocal Services Agreement (now known as a Shared Services Agreement) for information technology equipment and support services (hereinafter referred to as the "Agreement"); and

WHEREAS, it has been determined that a change to the Agreement is necessary to incorporate a change in Paragraph F. Duration of the Agreement; and

WHEREAS, the attached Amendment No. 1 to the Interlocal Services Agreement for Information Technology Equipment and Support Services between the Township of West Deptford and the West Deptford Board of Education has been prepared outlining the change in the duration of the Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey that the Township Committee does hereby authorize and approve the execution of the attached Amendment No. 1 to the Interlocal Services Agreement Between the Township of West Deptford and the West Deptford Board of Education For Information Technology Equipment and Support Services.

BE IF FURTHER RESOLVED that the Mayor and/or Township Administrator be and is hereby authorized to execute any and all documents related to this approval.

AMENDMENT NO. 1 TO INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE WEST DEPTFORD BOARD OF EDUCATION FOR INFORMATION TECHNOLOGY EQUIPMENT AND SUPPORT SERVICES

THIS AMENDMENT, is made this 12th day of June, 2017, to the Interlocal Services Agreement between the Township of West Deptford and the West Deptford Board of Education for information technology equipment and support services, by and between the Township of West Deptford (hereinafter referred to as "WDT"), and the West Deptford Board of Education (hereinafter referred to as "WDBOE") and collectively referred to as the "Parties".

WITNESSETH

WHEREAS, the parties entered into an Interlocal Services Agreement (now known as a Shared Services Agreement) for information technology equipment and support services on or about December 7, 2016; and

WHEREAS, the parties agree that paragraph **F. DURATION OF AGREEMENT**, is hereby amended to read as follows:

This Agreement shall be effective for a period of five (5) years December 1, 2016 to November 30, 2021. Either party may take appropriate action to terminate the Agreement prior to its expiration date in the event of breach of the terms and provisions of the Agreement by the other party.

Notwithstanding any other provision of this Agreement, WDT or WDBOE may terminate this Agreement without cause if the terminating party determines that such a termination is in its best interest with ninety (90) days' notice. Each party shall give yearly notice in January of their respective intent to continue with the Agreement for the year given the necessary budget implications to either party should the Agreement be terminated, Said notice to terminate shall be in writing and become valid in ninety (90) days.

WHEREAS, the Parties agree that if Amendment No. 1 is terminated in any regard, the duration of the agreement shall revert back to the terms as outlined in the original Agreement; and


WHEREAS, all other terms and conditions of the aforesaid original Agreement shall remain in full force and effect.
