**RESOLUTION 2017- 225**

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING SETTLEMENT OF LITIGATION MATTER BETWEEN THE COUNTY OF CAMDEN VERSUS WEST DEPTFORD TOWNSHIP AND PAYMENT OF \$5,500.00 AS PART OF THE SETTLEMENT**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") was involved in litigation commenced in the Camden County Superior Court entitled County of Camden v. West Deptford Township, under Docket No. L-4466-16; and

**WHEREAS**, the litigation involved the question of reimbursement of certified costs expended by the Camden County Police Department (CCPD) in examining, hiring and training of officers of the CCPD who then left the CCPD to join other local governmental law enforcement agencies; and

**WHEREAS**, the Parties desire to amicably settle this matter without the need for further Court intervention; and


**WHEREAS**, as part of the settlement, the Township shall pay Five Thousand, Five Hundred Dollars (\$5,500) to the County of Camden toward reimbursement of certified costs expended by the Camden County Police Department (CCPD) in examining, hiring and training of officers of the CCPD who then left the CCPD to join other local governmental law enforcement agencies including the Township of West Deptford.

**NOW BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey does hereby authorize and approve the payment of Five Thousand, Five Hundred Dollars (\$5,500) to the County of Camden toward reimbursement of certified costs expended by the Camden County Police Department (CCPD) in examining, hiring and training of officers of the CCPD who then left the CCPD to join other local governmental law enforcement agencies including the Township of West Deptford, as settlement of litigation commenced in the Camden County Superior Court entitled County of Camden v. West Deptford Township, under Docket No. L-4466-16.

**BE IT FURTHER RESOLVED** that the Mayor and/or Township Administrator is authorized to execute any and all documents relating to the payment of these funds.

**ADOPTED** at the meeting of the Township Committee of the Township of West Deptford held on July 19, 2017.
