**RESOLUTION #2017-255**

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD CANCELING APPROPRIATIONS UNDER BOND ORDINANCE 2010-08 AND BOND ORDINANCE 2012-07.**

**WHEREAS**, the Township of West Deptford, New Jersey (the "Township") authorized various projects under Bond Ordinance Number 2015-08 and Bond Ordinance Number 2012-07 (the "Bond Ordinances");

**WHEREAS**, the Township desires to cancel certain appropriations under the Bond Ordinances;

**NOW, THEREFORE, BE IT RESOLVED** BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST DEPTFORD, IN THE COUNTY OF GLOUCESTER, NEW JERSEY (not less than a majority of all members thereof affirmatively concurring) AS FOLLOWS:


Section 1. The appropriation in the amount of \$75,047 authorized pursuant to Bond Ordinance #2010-08 entitled "REFUNDING BOND ORDINANCE PROVIDING FOR THE REFUNDING OF THE TOWNSHIP'S OUTSTANDING CALLABLE GENERAL OBLIGATION REFUNDING BONDS, SERIES A OF 2009, DATED JULY 1, 2009; AUTHORIZING THE ISSUANCE OF UP TO \$8,550,000 OF REFUNDING BONDS OF THE TOWNSHIP OF WEST DEPTFORD, COUNTY FO GLOUCESTER, NEW JERSEY, TO FINANCE THE COSTS THEREOF; MAKING CERTAIN DETERMINATIONS AND COVENANTS IN CONNECTION THEREWITH; AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING" is hereby cancelled.

Section 2. The appropriation in the amount of \$1,470,354.50 authorized pursuant to Bond Ordinance #2012-07 entitled "REFUNDING BOND ORDINANCE PROVIDING FOR PAYMENT OF AMOUNTS OWING TO OTHERS FOR TAXES LEVIED IN AND BY THE TOWNSHIP OF WEST DEPTFORD, COUNTY OF GLOUCESTER, NEW JERSEY, APPROPRIATING NOT TO EXCEED \$33,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$33,000,000 BONDS OR NOTES OF THE TOWNSHIP FOR FINANCE THE COST THEREOF" is hereby cancelled.

Section 3. This Resolution shall take effect upon its adoption.


