**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE AWARD OF
A CONTRACT FOR SUPPLYING INFLATABLE AND MECHANICAL RIDES FOR WEST
DEPTFORD FAMILY FUN DAY AT THE RIVERWINDS COMMUNITY CENTER
(CIRCUS TIME AMUSEMENTS AND ENTERTAINMENT)**

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day to be held at the RiverWinds Community Center on September 23, 2017 (Rain Date September 24, 2017); and

WHEREAS, the Township has solicited for quotes for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day; and

WHEREAS, the Township received one proposal on August 9, 2017 from Circus Time Amusements and Entertainment (hereinafter referred to as "Circus Time"), which is attached hereto and incorporated herein; and

WHEREAS, Circus Time submitted the lowest responsible and responsive proposal for the supplying of inflatable and mechanical rides for West Deptford Family Fun Day in an amount of \$10,265.00 as provided in the proposal submitted to the Township; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 16th day of August, 2017, that a contract be and is hereby awarded to Circus Time Amusements and Entertainment of Pennsauken, New Jersey in the amount of \$10,265.00 as provided in the proposal submitted to the Township, for the supplying of inflatable and mechanical rides for West Deptford Family

Fun Day to be held at the RiverWinds Community Center on September 23, 2017 (Rain Date: September 24, 2017), subject to all terms and conditions contained in the bid package.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements with respect to the award of said contract.


