RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING RENEWAL OF A STATEMENT OF TRAINING AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND ROWAN UNIVERSITY FOR THE USE OF STUDENTS FROM THE ROWAN UNIVERSITY DEPARTMENT OF HEALTH AND EXERCISE SCIENCE (HES) AS INTERNS AT THE RIVERWINDS COMMUNITY CENTER FOR THE YEAR 2018

WHEREAS, Rowan University (hereinafter referred to as "Rowan") offers instruction in selected health-related disciplines; and

WHEREAS, as part of each program, Rowan seeks relevant, supervised experiences in practice settings for its students to participate in; and

WHEREAS, Rowan maintains educational programs in its Department of Health and Exercise Science (hereinafter referred to as "HES") and seeks training opportunities for its HES students; and

WHEREAS, the RiverWinds Community Center provides quality experiential opportunities for HES interns where the student may perform with high standards at all times and comply with all of the policies and regulations of the appropriate department to which the student is assigned; and

WHEREAS, both Rowan and the Township of West Deptford (hereinafter referred to as "Township"), as owner and operator of the RiverWinds Community Center, desire to maintain and improve the overall health and wellness of the population and education by engagement in a setting that promotes health and wellness; and

WHEREAS, both Rowan and the Township believe the education of the student intern(s) shall complement the service and educational activities of the RiverWinds Community Center; and

WHEREAS, the student intern(s) shall be under the supervision of an onsite supervisor, acceptable to both Rowan and the Township, and shall not be used in lieu of professional or staff personnel at the RiverWinds Community Center; and

WHEREAS, the student intern(s) will receive academic credit for the mentored experience at the RiverWinds Community Center; and

WHEREAS, it is in the mutual interest and advantage to both Rowan and the Township to enter

into an Agreement that provides the student intern(s) with the opportunity and benefit of receiving training in their desired field of study; and

WHEREAS, the attached Statement of Training Agreement ("Agreement") outlines the terms and conditions for the use of interns from the Rowan University Department Of Health And Exercise Science (HES) at the RiverWinds Community Center; and

WHEREAS, the Agreement automatically renews each year unless either party notifies the other party of its intention not to renew; and

WHEREAS, the Township Committee approves the continued participation with Rowan University in this Agreement.


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:
