RESOLUTION #2018 - 69

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING CHANGE ORDER #2 TO GERALD A. BARRETT, LLC FOR THE RECONSTRUCTION OF ROOSEVELT BOULEVARD AND RIVERVIEW AVENUE

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") awarded a contract for the reconstruction of Roosevelt Boulevard and Riverview Avenue in the Township to Gerald A. Barrett, LLC, pursuant to Resolution #2017-164 adopted on April 19, 2017, in the total amount of \$149,082.97; and

WHEREAS, it was determined that a Change Order #1 to the original contract was required for the additional work to address as-built quantities as well as the addition of the unclassified excavation required to stabilize a section of the roadway; and

WHEREAS, Gerald A. Barrett, LLC submitted a proposal dated October 9, 2017 outlining the costs of the additional work in the amount of \$251.34; and

WHEREAS, T&M Associates submitted a letter dated October 10, 2017 outlining the additional costs for the above and recommending Change Order #1 in the amount of \$251.34 for a revised total contract amount of \$149,334.31; and

WHEREAS, it has been determined that a Change Order #2 to the original contract is required for the additional work to address crack repairs in the Knoll's bituminous driveway using surface course asphalt and asphalt pavement sealer; and

WHEREAS, Gerald A. Barrett, LLC has submitted a proposal dated November 1, 2017 outlining the costs of the additional work in the amount of \$6,047.31; and


WHEREAS, T&M Associates has submitted a letter dated December 21, 2017, and attached hereto, outlining the additional costs for the above and recommending Change Order #2 in the amount of \$6,047.31 for a revised total contract amount of \$155,381.62.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 17th day of January, 2018 that

the Township of West Deptford does hereby authorize Change Order #2 to the contract with Gerald A. Barrett, LLC for the reconstruction of Roosevelt Boulevard and Riverview Avenue in the amount of \$6,047.31 for a revised total contract amount of \$155,381.62.


