**RESOLUTION AUTHORIZING ENDORSEMENT IN SUPPORT OF THE STATE OF NEW JERSEY DEPARTMENT OF TRANSPORTATION'S (NJDOT) ROUTE 295 RAMP "S" BRIDGE OVER ROUTE 45 SOUTHBOUND (SB) IMPROVEMENTS PROJECT**

**WHEREAS**, it has been determined that the Route 295 Ramp "S" over Route 45 Southbound in the Township of West Deptford (hereinafter referred to as "Township") is in need of repair; and

**WHEREAS**, the bridge deck is in a deteriorated condition and aged to the point that maintenance is not an effective measure to keep the bridge deck in serviceable condition; and

**WHEREAS**, the New Jersey Department of Transportation (hereinafter referred to as "NJDOT") has developed a project for the replacement of the bridge deck for the Route 295 Ramp "S" Bridge over Route 45 Southbound; and

**WHEREAS**, the Township Committee and Officials have been provided with the attached Project Fact Sheet for replacement of the bridge deck; and


**WHEREAS**, the Township Committee has determined that this project is in the best interest of the Township and desires to endorse and support the NJDOT's Project.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, as follows:


1. The Township Committee hereby approves and authorizes endorsement of the State of New Jersey Department of Transportation's (NJDOT) Route 295 Ramp "S" Bridge over Route 45 Southbound (SB) Improvements Project.
2. The Township Committee hereby authorizes and directs the Municipal Clerk to forward a letter to the NJ DOT indicating support for the replacement of the bridge deck for the Route 295 Ramp "S" Bridge over Route 45 Southbound.
3. The Municipal Clerk is further directed to forward such letter to the NJDOT with this Resolution attached, expressing its support for this project.
