RESOLUTION 2017- 103

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE ACCEPTANCE OF A VOLUNTARY DONATION FROM THE WEST DEPTFORD FIELD OF DREAMS, INC. ("WDFOD") FOR THE MAINTENANCE OF THE FIELD OF DREAMS PLAYGROUND IN THE TOWNSHIP OF WEST DEPTFORD

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") owns and maintains a playground known as the Field of Dreams located at 42 River Lane in the Township; and

WHEREAS, West Deptford Field of Dreams Corporation, Inc. (hereinafter referred to as "WDFOD") is a non-profit corporation of the State of New Jersey which raised funds and accepted donations to be used for the Field of Dreams playground; and

WHEREAS, the Board of WDFOD is in the process of dissolving the corporation; and

WHEREAS, as part of the dissolution, WDFOD desires to donate its corporation's cash assets, to the Township to be used solely for the maintenance of the Field of Dreams playground; and


WHEREAS, the funds from WDFOD will be donated in increments to the Township, with the final donation of funds being made upon the completion of the dissolution of the WDFOD; and

WHEREAS, all donated funds from WDFOD will be placed in a Township dedicated account to be used solely for the maintenance of the Field of Dreams.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey that the Township Committee does hereby authorize and accept the voluntary donation of funds from the West Deptford Field of Dreams, Inc. ("WDFOD") to the Township of West Deptford to be used solely for the maintenance of the Field of Dreams playground located in the Township of West Deptford.
