RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING THE EXECUTION OF A PROFESSIONAL SERVICE CONTRACT PURSUANT
TO N.J.S.A. 40A:11-5(1)(a)(i) FOR AN ACCOUNTANT TO COMPLETE A PAYROLL AUDIT
FOR THE YEAR 2019

WHEREAS, West Deptford Township has determined there exists a need to acquire the services of an accountant to complete a payroll audit pursuant to the provisions of N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, this one (1) year contract shall commence on February 20, 2019 and terminate on December 31, 2019 for an amount not to exceed \$17,500; and

WHEREAS funding for this contract shall be encumbered by the West Deptford Township Finance Officers in accordance with N.J.A.C. 5:30-5.4.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey as follows:

1. That Bowman & Company LLP be and is hereby appointed as the Accountant to complete a payroll audit for the Township of West Deptford for the year commencing February 20, 2019 and ending December 31, 2019 pursuant to N.J.S.A. 40A:11-5(1)(a)(i).
2. That the Mayor and Municipal Clerk are hereby authorized and directed to execute a contract with Bowman & Company LLP in an award amount not to exceed \$17,500. A Notice stating the nature, duration, service and the amount of the contract and that this Resolution and contract are on file and available for public inspection in the office of the Township Clerk shall be published in The South Jersey Times and/or Courier Post.
