**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD APPROVING THE PERSON TO PERSON TRANSFER OF PLENARY RETAIL DISTRIBUTION LICENSE, LICENSE #0820-44-013-002 FROM G'S LIQUOR GALLERY, LLC TO YOGI KI KRUPA, INC.**

**WHEREAS**, an application has been filed for a Person-to-Person Transfer of Plenary Retail Distribution License, License #0820-44-013-002, hereinto issued to G's Liquor Gallery, LLC for premises located at 997 Kings Highway, West Deptford, New Jersey; and

**WHEREAS**, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

**WHEREAS**, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey does hereby approve, effective April 11, 2017, the transfer of the aforesaid Plenary Retail Distribution License, License #0820-44-013-002 to Yogi Ki Krupa, Inc. and does hereby direct the Registered Municipal Clerk to endorse the license certificate to the new ownership as follows: "This license, subject to all its terms and conditions, is hereby transferred to Yogi Ki Krupa, Inc., effective April 11, 2017."
