RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING THE REMOVAL OF WATER AND SEWER CHARGES
REPRESENTING DEDUCTIONS FOR
QUALIFYING SENIOR CITIZENS AND DISABLED PERSONS
AT THE WILLOW WOODS MOBILE HOME PARK

WHEREAS, the Township of West Deptford provides a 10 per cent reduction in water charges for qualifying senior citizens and/or totally and permanently disabled persons; and

WHEREAS, the monthly water discount for qualifying senior citizens and disabled persons living in such park was determined to be \$8.80 per month in 2016; and

WHEREAS, the total of these deductions granted to qualifying senior citizens and disabled persons for the year 2016 is to be deducted from the water accounts of The Carlyle Group, owner of the Willow Woods Mobile Home Park; and

WHEREAS, the removal of water charges requires the authorization of the governing body.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester, State of New Jersey, that removal of the following charges be approved and that the Chief Financial Officer is hereby authorized and directed to affect the same:


