RESOLUTION 2017- 212

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD TO AMEND ADOPTED BUDGET
(CHAPTER 159) FOR SPECIAL ITEMS OF REVENUE
AND APPROPRIATION N.J.S.A. 40A:4-87

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of the Township of West Deptford when such items shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for an equal amount; and

WHEREAS, the Township of West Deptford will receive \$514.72 from the Alcohol Education Rehabilitation Enforcement Fund and wishes to amend its 2017 Budget to include a portion of this amount as a revenue.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of West Deptford hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2017 in the sum of \$514.72, which is now available as revenue from:

Miscellaneous Revenues
Special Items of General Revenue Anticipated with Prior
Written Consent of the Director of Local Government Services:
Public and Private Revenues Offset with Appropriations:
Alcohol Education, Rehabilitation Enforcement Fund; and

BE IT FURTHER RESOLVED that a like sum of \$514.72 be and the same is hereby appropriated under the caption of:

General Appropriations
(a) Operations Excluded from CAP
Public and Private Programs Offset by Revenues:
Alcohol Education Rehabilitation Enforcement Fund
Other Expenses \$514.72

BE IT FURTHER RESOLVED, that the Township Clerk forward two copies of this resolution to the Director of Local Government Services.
