RESOLUTION 2017 250

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING CONTRACTS WITH CERTAIN APPROVED NATIONAL JOINT POWERS ALLIANCE VENDORS FOR CONTRACTING UNITS PURSUANT TO N.J.S.A. 52:34-6.2 (b) (3)

WHEREAS, the Township of West Deptford, pursuant to N.J.S.A. 52:34-6.2 (b) (3) and, may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Township of West Deptford has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, the Township of West Deptford intends to enter into contracts with the attached Referenced National Joint Powers Alliance Vendors through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current National Joint Powers Alliance contracts;


NOW, THEREFORE, BE IT RESOLVED, that the Township of West Deptford authorizes the Purchasing Agent to purchase certain goods or services from those approved National Joint Powers Alliance Vendors on the attached list, pursuant to all conditions of the individual contracts; and

BE IT FURTHER RESOLVED, that the governing body of the Township of West Deptford pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing order, and a certification of availability of funds is made by the Chief Financial Officer; and

BE IT FURTHER RESOLVED that the duration of this authorization shall be until December 31, 2017 or upon the expiration of the vendors' contract, whichever event first occurs.
