RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF A LEASE AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE COUNTY OF GLOUCESTER FOR PREMISES LOCATED AT 1267 HESSIAN AVENUE IN THE TOWNSHIP OF WEST DEPTFORD

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") owns land and all improvements located thereon at 1267 Hessian Avenue in the Township and known as Block 118/Lot 77; and

WHEREAS, the County of Gloucester (hereinafter referred to as "County") and the Township have entered into a Shared Services Agreement for the provision of basic life support emergency medical services (hereinafter referred to as "Shared Services Agreement"); and

WHEREAS, pursuant to the Shared Services Agreement, the County has agreed to provide basic life support emergency medical services to the Township; and

WHEREAS, consistent with the terms of the Shared Services Agreement, the Township has agreed to lease the premises located at 1267 Hessian Avenue to the County to be used to operate a Basic Life Support ambulance services; and

WHEREAS, the term of the Lease Agreement shall be for ten (10) years commencing September 30, 2017 and concluding September 29, 2027; and

WHEREAS, a Lease Agreement has been prepared for the premises located at 1267 Hessian Avenue in the Township of West Deptford.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 16th day of August, 2017 that the Township of West Deptford does hereby authorize the execution of a Lease Agreement between the Township of West Deptford and the County of Gloucester lease of premises located at 1267 Hessian Avenue in the Township of West Deptford to be used, by the County, to operate a

Basic Life Support ambulance service; and

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate documents and agreements respecting this matter.
