**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD APPROVING CONTRACT WITH NERI'S CONSTRUCTION AND RENTALS, INC. FOR THE KINGS HIGHWAY WATERLINE REPAIR PROJECT (NUNC PRO TUNC)**

**WHEREAS**, Neri's Construction and Rentals, Inc., of Williamstown, New Jersey, has been awarded a contract for general maintenance and/or repair of Township of West Deptford Municipal Utility Systems for the years 2017 and 2018; and

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for maintenance and repair to a water main located on Kings Highway and to be known as the Kings Highway Waterline Repair Project (hereinafter referred to as the "Project"); and

**WHEREAS**, Neri's Construction and Rentals, Inc. has submitted the attached Proposal to complete the maintenance and repair to the water main located on Kings Highway; and

**WHEREAS**, the Township Engineer, the Township Water/Sewer Superintendent and the Township Administrator have recommended that the Township Committee award a contract for the maintenance and repair to the water main located on Kings Highway to Neri's Construction and Rentals, Inc. for an amount not to exceed \$69,270; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this Contract, the original of said Certification is attached to the original of this Resolution and shall be filed in the office of the Township Clerk.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that Neri's Construction and Rentals, Inc., of Williamstown, New Jersey, be and is hereby awarded a contract for Option #5 for the Kings Highway Waterline Repair Project in the amount not to exceed \$69,270, nunc pro tunc.

**BE IT FURTHER RESOLVED**, that the Mayor and/or Township Administrator be and is

hereby authorized to execute a contract for said project on behalf of the Township of West Deptford.


