RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF AN ALLIANCE TO PREVENT ALCOHOLISM AND DRUG ABUSE AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE COUNTY OF GLOUCESTER

WHEREAS, the Alliance to Prevent Alcoholism and Drug Abuse (“Alliance”) was created in the Governor’s Council on Alcoholism and Drug Abuse to create a network comprised of all the communities in New Jersey, which is dedicated to a comprehensive and coordinated effort against alcoholism and drug abuse; and

WHEREAS, the Alliance shall be a mechanism both for implementing policies to reduce alcoholism and drug abuse at the municipal level, and for providing funds, including moneys from mandatory penalties on drug offenders, to member communities to support appropriate county and municipal based alcohol and drug abuse education and public awareness activities; and

WHEREAS, the Township of West Deptford (hereinafter referred to as “Township”) desires to participate in the Alliance; and

WHEREAS, the County of Gloucester (hereinafter referred to as “County”) acts as the grant administrator for the Governor’s Council on Alcoholism and Drug Abuse and on behalf of the Township for participation in the Alliance to Prevent Alcoholism and Drug Abuse; and

WHEREAS, the attached Agreement has been prepared outlining the terms and conditions of the Township’s participation in the Alliance;

WHEREAS, under the Agreement, funds will be issued to the Township by the County in the amount not to exceed \$19,920 to provide for alcohol and drug abuse education and public awareness activities in the Township of West Deptford which adhere to the scope and purposed of the Governor’s Council on Alcoholism and Drug Abuse; and

WHEREAS, the Agreement will be valid for the period of July 1, 2017 to June 30, 2018 contingent upon full compliance with all terms and conditions as outlined in the Agreement.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 4th day of October, 2017 that the Township of West Deptford does hereby authorize the execution of the attached Alliance to Prevent Alcoholism and Drug Abuse Agreement between the Township of West Deptford and the County of Gloucester for participation in the Alliance to Prevent Alcoholism and Drug Abuse and receipt of funds in the amount of \$19,920 to provide for alcohol and drug abuse education and public awareness activities in the Township of West Deptford.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are hereby authorized to execute all appropriate documents and agreements regarding this matter.




