RESOLUTION #2017-306

RESOLUTION AUTHORIZING THE TOWNSHIP OF WEST DEPTFORD TO ENTER INTO A JOINT PURCHASING AGREEMENT WITH THE SOUTH JERSEY POWER COOPERATIVE FOR THE PURCHASE OF NATURAL GAS SERVICES

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") desires to enter into a joint purchasing agreement for the purchase of natural gas services; and

WHEREAS, N.J.S.A. 40A:11-10(a)(1) authorizes contracting units to establish a Joint Purchasing System and to enter into a Joint Purchasing Agreement for its administration; and

WHEREAS, the County of Camden, as Lead Agency to the South Jersey Power Cooperative (hereinafter referred to as the "Lead Agency"), has offered voluntary participation in a Joint Purchasing System for the provision and performance of goods and services and the procurement of natural gas; and

WHEREAS, on November 8, 2017 the governing body of the Township of West Deptford, County of Gloucester, State of New Jersey duly considered participation in a Joint Purchasing System for the provision of goods and services and the procurement of natural gas.

NOW THEREFORE BE IT HEREBY RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey as follows:

1. That this Resolution shall be known and may be cited as the Joint Purchasing Resolution of The Township of West Deptford.
2. That pursuant to the provisions of N.J.S.A. 40A:11-10(a)(1) the Purchasing Agent of West Deptford Township is hereby authorized to enter into a Joint Purchasing Agreement with the Lead Agency, County of Camden, under contract with **SOUTH JERSEY POWER COMPANY** for natural gas services under P.D. 10-041.
3. That the Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1) and all other provisions of the revised statutes of the State of New Jersey.


