RESOLUTION 2017 - 312

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD REJECTING ALL BIDS RECEIVED ON OCTOBER 20, 2017 FOR THE RIVERWINDS COMMUNITY CENTER POOL ROOF AND BUILDING IMPROVEMENTS AND AUTHORIZING RE-ADVERTISEMENT OF THE PROJECT

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the RiverWinds Community Center pool roof and building improvements; and

WHEREAS, the Township advertised for public bids for the RiverWinds Community Center pool roof and building improvements; and

WHEREAS, two sealed bids for the RiverWinds Community Center pool roof and building improvements were received and opened on October 20, 2017 as follows:

WHEREAS, a review of the bid by the Township's Engineer determined that the bid received exceeded the Engineer's cost estimate and the Township of West Deptford's appropriation for the contract pursuant to N.J.S.A. 40A:11-13.2(a) and (b); and

WHEREAS, pursuant to the October 27, 2017 letter from the Township's Engineer, T&M Associates attached hereto, it is recommended that the bids received and opened on October 20, 2017 be rejected for the reasons stated above and that the project be re-advertised.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey as follows:


1. That the bids received from Aliano Brothers General Contractors, Inc. and D.A. Nolt, Inc. and opened on October 20, 2017 for the RiverWinds Community Center pool roof and building improvements are hereby rejected for the reasons

above stated.

2. That the Township Clerk is hereby authorized to re-advertise the RiverWinds Community Center pool roof and building improvements project for receipt of bids.
