RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING REFUND TO JESSICA HELLINGER (MEDINA BUILDING MAINTENANCE AND RESTORATION LLC) FOR PURCHASE OF SCRAP METERS FROM ONLINE AUCTION

WHEREAS, pursuant to Resolution 2017-283, adopted on October 4, 2017, the Township of West Deptford (hereinafter referred to as "Township") authorized the sale of surplus personal property no longer needed for public use on an online auction site; and

WHEREAS, included in surplus personal property were several hundred scrap meters; and

WHEREAS, the successful bid for the scrap meters in the amount of \$2,700 was made by Jessica Hellinger from Medina Building Maintenance and Restoration LLC; and

WHEREAS, after the bid was awarded, it was determined that the total count of scrap meters was short by 45 meters; and

WHEREAS, the Township desires to issue a refund to the successful bidder for the scrap meters she did not receive; and

WHEREAS, it has been determined by the West Deptford Township Water and Sewer Superintendent that a fair and equitable price for the meters listed for sale on the site was \$8.58 per meter; and

WHEREAS, the amount of the refund to be issued to the successful bidder will be in the amount not to exceed \$500 as follows:

\$8.58/meter x 45 meters	\$386.10
<u>Pickup charges (gas/toll/etc)</u>	<u>\$113.90</u>
Total Refund Amount	\$500.00



WHEREAS, the West Deptford Township Water and Sewer Superintendent has prepared a memo dated November 2, 2017 and attached hereto, outlining the reasons for the refund.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 8th day of November, 2017 that the Township of West Deptford does hereby authorize and approve a refund in the amount of \$500 to Jessica Hellinger of Medina Building Maintenance and Restoration LLC for the purchase of scrap meters not received, per the Memo prepared by the West Deptford Water and Sewer Superintendent and dated November 2, 2017.
