RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD  
AUTHORIZING THE EXECUTION OF A PROFESSIONAL SERVICE CONTRACT  
PURSUANT TO A FAIR AND OPEN PROCESS TO PROVIDE ARCHITECT SERVICES FOR  
THE YEAR 2017

**WHEREAS**, West Deptford Township has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of N.J.S.A. 19:44A-20-5; and

**WHEREAS**, N.J.S.A. 19:44A-20-5 provides that contracts awarded through a fair and open process may be awarded based on price and other factors; and

**WHEREAS** West Deptford Township has determined there exists a need to acquire the services of an **Architect** as a fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20-5; and

**WHEREAS**, this contract shall commence on February 1, 2017 and terminate on December 31, 2017; and

**WHEREAS**, on January 24, 2017, **Bach Associates** submitted a responsive and responsible proposal, price and other factors considered, to provide Architect services for the Township of West Deptford; and

**WHEREAS**, funding for this contract shall be encumbered by the West Deptford Township Finance Officers in accordance with N.J.A.C. 5:30-5.4;


**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, Gloucester County, New Jersey, as follows:

1. That **Bach Associates** be and is hereby appointed Architect for the Township of West Deptford for the year 2017 commencing February 1, 2017, and ending December 31, 2017.
2. That the Mayor and Municipal Clerk are hereby authorized and directed to execute a contract with **Bach Associates** as Architect for a fee of **\$145.00 per hour** for services as defined in the contract. Said contract is awarded in compliance with rules and restrictions of N.J.S.A. 19:44A-20-5 and Township Ordinance Creating Fair and Open Process.
3. A Notice stating the nature, duration, service and the amount of the contract and that this Resolution and contract are on file and available for public inspection in the office of the Township Clerk shall be published in *The South Jersey Times and/or Courier Post*.
