**RESOLUTION AUTHORIZING THE TOWNSHIP OF WEST DEPTFORD TO ACCEPT A SUBAWARD UNDER SUBAWARD NUMBER 18-0820 IN THE AMOUNT OF \$60,000 UNDER THE 2018 SAFE AND SECURE COMMUNITIES PROGRAM AND AUTHORIZING EXECUTION OF ALL DOCUMENTS REGARDING SAME**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") applied for approximately \$60,000.00 in State funding with a Township match of \$175,862.90 for a proposed project total cost of \$235,862.90 through the State of New Jersey Safe and Secure Communities Subgrant Program, Number 18-0820, for the time period from March 18, 2018 to March 17, 2019; and

**WHEREAS**, the Township application for State funding in the amount of \$60,000 was accepted under Subaward Number 18-0820 for the time period from March 18, 2018 to March 17, 2019; and

**WHEREAS**, the Mayor and Township Committee are authorized to accept Subaward Number 18-0820 in the amount of \$60,000 on behalf of the Township; and

**WHEREAS**, the project is a joint effort between the New Jersey Department of Law and Public Safety and the Township of West Deptford by accepting the specific grant funds for the purpose described in the application; and

**WHEREAS**, the Mayor and/or the Township Administrator are hereby authorized to execute any and all documents regarding the acceptance of Subaward Number 18-0820 in the amount of \$60,000.



2. The Mayor and/or Township Administrator are hereby authorized to execute any and all documents regarding the acceptance of Subaward Number 18-0820.




