RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE PURCHASE OF ONE (1) 2017 SEAGRAVE CUSTOM PUMPER BY THE TOWNSHIP OF WEST DEPTFORD AS PART OF THE HOUSTON-GALVESTON AREA COUNCIL NATIONAL COOPERATIVE PURCHASING PROGRAM

WHEREAS, N.J.S.A. 52:34-6.2(b)(3) authorizes contracting units to purchase goods, or to contract for services, through the use of a nationally recognized and accepted cooperative purchasing agreement that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other State, when available; and

WHEREAS, Houston-Galveston Area Council ("H-GAC") is a nationally recognized and accepted cooperative purchasing contracting unit within the State of Texas that utilizes a competitive bid or competitive proposal processing awarding contracts for goods and services and is authorized by Texas law to extend its contracts to local government units nationwide; and

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") authorized membership in the H-GAC Cooperative Purchasing Program pursuant to Resolution 2013-137 adopted on September 19, 2013; and

WHEREAS, the Township proposes to purchase one (1) 2017 Seagrave Custom Pumper for the Thorofare Fire Company located in the Township through the Houston-Galveston Area Council ("H-GAC") Cooperative Purchasing Program, Contract #FS12-17, effective December 1, 2017 through November 30, 2019.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 18th day of April, 2018 that the Township of West Deptford does hereby authorize and approve the purchase of one (1) 2017 Seagrave Custom Pumper for the Thorofare Fire Company located in the Township through the Houston-Galveston Area Council ("H-GAC") Cooperative Purchasing Program,

Contract, Contract #FS12-17, effective December 1, 2017 through November 30, 2019, in the total amount of \$699,868.00.




