RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE EXECUTION OF A WATER SUPPLY INTERCONNECTION AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE BOROUGH OF WOODBURY HEIGHTS (GRISCOM LANE AND ROUTE 45)

WHEREAS, the Water Supply Management Act Rules, N.J.A.C. 7:19-6, et seq., promulgated by the New Jersey Department of Environmental Protection (NJDEP) permit the interconnection of adjacent water supply systems; and

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") and the Borough of Woodbury Heights (hereinafter referred to as "Borough") have for many years maintained an interconnection of their water supply systems at Griscom Lane and Route 45 for use in times of emergency; and

WHEREAS, the said NJDEP rules, specifically N.J.A.C. 7:19-6.9(g) require that entities maintaining interconnected systems enter into a written agreement setting forth the conditions for use of the interconnection, which agreement must be filed with and approved by NJDEP; and

WHEREAS, a Water Supply Interconnection Agreement ("Agreement") between the Township and the Borough has been prepared and attached hereto memorializing the conditions which have been understood and adhered to between the parties for many years pertaining to the pre-existing interconnection at Griscom Lane and Route 45 in order to comply with the said NJDEP requirement for an approved written agreement; and


WHEREAS, both the Township and the Borough have reviewed the Agreement and desire to enter into same.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 18th day of April, 2018 that the Township of West Deptford does hereby authorize the execution of a Water Supply

Interconnection Agreement between the Township of West Deptford and the Borough of Woodbury Heights regarding the interconnection located at Griscom Lane and Route 45.




