**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING EXECUTION OF A SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE COUNTY OF GLOUCESTER TO PROVIDE FAMILY MOVIE ENTERTAINMENT AT RIVERWINDS ON AUGUST 15, 2018 (RAIN DATE AUGUST 16, 2018)**

**WHEREAS**, the Township of West Deptford desires to host a family-oriented movie night at the RiverWinds Community Center on August 15, 2018 (rain date August 16, 2018); and

**WHEREAS**, the County of Gloucester Department of Parks and Recreation has certain expertise in planning events of this nature and has contracted with vendors to provide recently released movies to participating municipalities; and

**WHEREAS**, the County of Gloucester has contracted to provide a recently released family-oriented movie to be shown, weather permitting, at dusk, on August 15, 2018 at RiverWinds (rain date August 16, 2018); and

**WHEREAS**, the Shared Services Act, N.J.S.A. 40A:65-1, et seq., specifically authorizes local government units, including, but not limited to, counties and authorities such as the Township and County to enter agreements for the provisions of Shared Services; and

**WHEREAS**, a Shared Services Agreement has been prepared to provide a recently released family-oriented movie to be shown, weather permitting, at dusk, on August 15, 2018 at RiverWinds (rain date August 16,2018); and

**WHEREAS**, this event will be arranged by the Gloucester County Department of Parks and Recreation at no cost to the Township of West Deptford; and

**WHEREAS**, the County of Gloucester will not be obligated to reimburse the Township of West Deptford for use of any of its facilities in the provision of the family movie entertainment.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 16<sup>th</sup> day of May, 2018 that the Township of West Deptford does hereby authorize the execution of a Shared Services Agreement between the Township of West Deptford and the County of Gloucester to provide family movie entertainment at RiverWinds on August 15, 2018 (rain date August 16,2 018); and

**BE IT FURTHER RESOLVED** that the Mayor is herein authorized to execute all appropriate contracts, documents and agreements regarding this matter.




