**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT FOR THE RIVERWINDS COMMUNITY CENTER POOL AREA AND BUILDING IMPROVEMENTS (ALIANO BROTHERS GENERAL CONTRACTORS, INC.)**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the RiverWinds Community Center pool area and building improvements; and

**WHEREAS**, the Township advertised for public bids for the RiverWinds Community Center pool area and building improvements; and

**WHEREAS**, two sealed bids for the RiverWinds Community Center pool area and building improvements were received and opened on May 10, 2018 as follows:

**WHEREAS**, the Township Engineer, by letter dated May 15, 2018 and attached hereto, has recommended the contract for the RiverWinds Community Center pool area and building improvements be awarded to Aliano Brothers General Contractors, Inc. for the base bid amount in the amount not to exceed \$598,300 and in accordance with the bid specifications; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this Contract, the original of said Certification is attached to the original of this Resolution and shall be filed in the office of the Township Clerk.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township

of West Deptford, County of Gloucester and State of New Jersey that Aliano Brothers General Contractors, Inc. is hereby awarded a contract for the RiverWinds Community Center pool area and building improvements for the base bid amount in the amount not to exceed \$598,300 and in accordance with the bid specifications.

**BE IT FURTHER RESOLVED**, that the Mayor and/or Township Administrator be and is hereby authorized to execute a contract for said project on behalf of the Township of West Deptford.






