RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT TO ITALIAN WATER ICE TO SUPPLY CONCESSION SERVICES FOR THE 2018 RIVERWINDS STREET FEST CONCERT SERIES AT THE RIVERWINDS COMMUNITY CENTER

WHEREAS, there exists a need in the Township of West Deptford ("Township") to provide concession services ("Services") at the 2018 RiverWinds Street Fest Concert Series located at the amphitheater adjacent to the RiverWinds Community Center in the Township of West Deptford; and

WHEREAS, the Township has solicited quotes for a Vendor to supply concession services at the 2018 RiverWinds Street Fest Concert Series; and

WHEREAS, the Township received one quote from Italian Water Ice located in Logan Township, New Jersey; and

WHEREAS, Italian Water Ice has submitted all the required information per the specifications to provide the Services; and

WHEREAS, the Purchasing Agent has reviewed the quote submitted and finds that the documents meet the specifications; and

WHEREAS, the specifications for the Services are incorporated by reference herein; and

WHEREAS, the Township desires to award a contract for a Vendor to supply concession services at a fee payable to the Township for said services for the 2018 RiverWinds Street Fest Concert Series at the RiverWinds Community Center, to Italian Water Ice, located in Logan Township, New Jersey, for payment to the Township of a fee \$1,500 as per the quote received.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 16th day of May, 2018, that a contract to supply concession services, at a fee payable to the Township for said services in the amount of \$1,500, be awarded to Italian Water Ice for the 2018 RiverWinds Street Fest Concert Series at the RiverWinds Community Center for the dates specified in the

specifications between June 2018 and August 2018; and

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.


