RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT TO BOTTO'S ITALIAN LINE RESTAURANT TO SUPPLY VENDOR SERVICES FOR THE 2018 RIVERWINDS STREET FEST CONCERT SERIES (NUN PRO TUNC)

WHEREAS, there exists a need in the Township of West Deptford ("Township") to supply vendor services ("Services") for the 2018 RiverWinds StreetFest Concert Series located at the amphitheater adjacent to the RiverWinds Community Center in the Township of West Deptford; and


WHEREAS, the Township desires to award a contract to Botto's Italian Line Restaurant, located in Swedesboro, New Jersey, to supply vendor services for the 2018 RiverWinds Streetfest Concert Series for payment to the Township of a fee of \$1,500 as per Township Ordinance 2018-02, adopted on March 15, 2018 and effective April 1, 2018.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 6th day of June, 2018, that a contract, in the form attached hereto and made a part hereof, be awarded to Botto's Italian Line Restaurant to supply vendor services for the 2018 RiverWinds Street Fest Concert Series at the RiverWinds Community Center for the specified concert dates between June 2018 and August 2018 and for payment to the Township for said services in the amount of \$1,500 as per Township Ordinance 2018-02, adopted on March 15, 2018 and effective April 1, 2018; and

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said contract.




