RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AND APPROVING THE EXECUTION OF THE SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST DEPTFORD AND THE GLOUCESTER COUNTY UTILITIES AUTHORITY FOR A C-3 LICENSED OR HIGHER PUBLIC WASTEWATER COLLECTION SYSTEM OPERATOR FOR THE OPERATION OF THE WEST DEPTFORD WASTEWATER COLLECTION SYSTEM

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need for a C-3 licensed or higher Public Wastewater Collection System Operator for the operation of the West Deptford Wastewater Collection System; and

WHEREAS, the Gloucester County Utilities Authority (hereinafter referred to as "GCUA") has the capabilities to provide these operator services to the Township; and

WHEREAS, the attached Shared Services Agreement (hereinafter referred to as "Agreement") has been prepared and outlines the responsibilities of each Party to the Agreement; and

WHEREAS, N.J.S.A. 40A:65-1 et seq. ("Shared Services Law") specifically authorizes local government units, including counties and municipalities, to enter into shared services agreements; and


WHEREAS, the Parties to this Shared Services Agreement agree that their mutual public purposes and their best interests will be promoted by the execution and delivery of this Agreement pursuant to the powers conferred by the Shared Services Law.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 20th day of June, 2018 that the Township of West Deptford does hereby authorize and approve the execution of the attached Shared Services Agreement Between the Township of West Deptford and the Gloucester County Utilities Authority for a C-3 Licensed or Higher Public Wastewater Collection System Operator for the Operation of the West Deptford Wastewater Collection System


pursuant to the terms of the attached Agreement.
