RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING AND APPROVING THE EXECUTION OF A CLINICAL AFFILIATION AGREEMENT WITH RUTGERS SCHOOL OF NURSING - CAMDEN

WHEREAS, Rutgers School of Nursing – Camden (hereinafter referred to as “Rutgers”) offers instruction in the area of nursing disciplines; and

WHEREAS, Rutgers maintains educational programs at its institution and seeks training opportunities for its nursing students; and

WHEREAS, the Township of West Deptford (hereinafter referred to as “Township”) operates a municipal summer recreation program in the Township which could provide quality opportunities for student nursing interns where the students may interact and perform in settings that are not limited to hospitals and like institutions; and

WHEREAS, both Rutgers and the Township believe the education of the student nursing interns shall complement the Township’s summer recreation program; and

WHEREAS, the student nursing interns shall be under the supervision of an onsite supervisor and shall not be used in lieu of professional or staff personnel of the Township; and

WHEREAS, the attached Clinical Affiliation Agreement (“Agreement”) outlines the terms and conditions for the use of student nursing interns from Rutgers School of Nursing – Camden during the Township’s summer recreation program; and

WHEREAS, it is in the mutual interest and advantage to both Rutgers and the Township to enter into an Agreement that provides the student nursing interns with the opportunity and benefit of receiving training in a setting such as the Township’s summer recreation program; and

WHEREAS, this Agreement shall be for a period of twelve (12) months and shall automatically renew from year to year unless either party gives at least 120 days notice to the other that the Agreement is to terminate on a certain date.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 20th day of June, 2018 that the Township of West Deptford does hereby authorize and approve the execution of the attached Clinical Affiliation Agreement between Rutgers School of Nursing – Camden and the Township of West Deptford for use of student nursing interns from Rutgers School of Nursing – Camden during the Township's summer recreation program.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator be and is hereby authorized to execute this Agreement and any documents related to same.
