**RESOLUTION 2018-183**

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING THE AWARD OF A CONTRACT FOR THE RESURFACING OF TWO INTERIOR POOLS AT THE RIVERWINDS COMMUNITY CENTER**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the resurfacing of the two interior pools at the RiverWinds Community Center (hereinafter referred to as the "Project"); and

**WHEREAS**, the Township has solicited and received bids for the Project; and

**WHEREAS**, the Township received the following bid proposals:

**WHEREAS**, the Add Alternate No. 1, as referenced above, includes pool lighting replacement consisting of six (6) LED lights in the Lap Pool and seven (7) LED lights in the Leisure Pool at the RiverWinds Community Center; and

**WHEREAS**, the Township desires to award a contract for the resurfacing of the two interior pools at the RiverWinds Community Center which includes the Add Alternate No. 1 for the pool lighting; and

**WHEREAS**, Main Line Commercial Pools, Inc. has submitted the lowest complete and responsive bid proposal for the resurfacing of the two interior pools at the RiverWinds Community Center with a total Base Bid amount of \$174,000 and an amount for Add Alternate No. 1 of \$7,500, for a total bid amount with alternate not to exceed \$181,500; and

**WHEREAS**, T&M Associates has provided the attached Letter of Recommendation for Contract Award to the Township dated June 28, 2018 recommending that the Township award the contract for the resurfacing of the two interior pools at the RiverWinds Community Center to

Main Line Commercial Pools, Inc. for the amount of Base Bid and Add Alternate No. 1 for a total contract amount not to exceed \$181,500.00; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 2nd day of July, 2018, that a contract be and is hereby awarded to Main Line Commercial Pools, Inc. for the resurfacing of the two interior pools at the RiverWinds Community Center, for a total Base Bid amount of \$174,000 and amount for Add Alternate No. 1 of \$7,500 for a total contract amount with alternate not to exceed \$181,500, subject to all terms and conditions contained in the bid package.

**BE IT FURTHER RESOLVED** that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.

**ADOPTED** at the meeting of the Township Committee of the Township of West Deptford held on July 2, 2018.
