RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AMENDING RESOLUTION #2018-172 – RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR THE REPLACEMENT OF GRANDVIEW PUMP STATION WASTEWATER FORCE MAIN (CROWN PIPELINE)

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") adopted Resolution #2018-172 authorizing the award of a contract for the replacement of Grandview Pump Station wastewater force main (hereinafter referred to as the "Project") to Crown Pipeline for the Base Bid amount of \$94,340 plus the amount for Bid Alternate No.1 in the amount of \$26,325 and Bid Alternate No. 2 in the amount of \$40,140 for a total contract amount not to exceed \$160,805; and

WHEREAS, after the award of the Contract, it was determined that Bid Alternate No. 2 for the Project is inclusive of Bid Alternate No. 1; and

WHEREAS, Crown Pipeline was still found to be the lowest responsible and responsive bid proposal with a total Base Bid amount of \$94,340.00 and an amount for Bid Alternate No. 2 of \$40,140.00 for the replacement of Grandview Pump Station wastewater force main for a total contract amount not to exceed \$134,480; and

WHEREAS, T&M Associates has provided the attached Letter of Recommendation for Contract Award to the Township dated July 2, 2018 recommending that the Township award the contract for the replacement of Grandview Pump Station wastewater force main to Crown Pipeline for the total Base Bid and Alternate No. 2 amount for a total contract amount not to exceed \$134,480; and

WHEREAS, Resolution #2018-172 shall be amended to reflect the correct total contract amount not to exceed \$134,480; and

WHEREAS, the balance of Resolution #2018-172 is correct and no further amendments or revisions are necessary.


NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 2nd day of July, 2018 as follows:

1. That Resolution #2018-172 authorizing the award of a contract for the replacement of Grandview Pump Station wastewater force main (hereinafter referred to as the "Project") to Crown Pipeline is hereby amended to reflect the correct total contract amount not to exceed \$134,480, which includes the Base Bid Amount of \$94,340 and Bid Alternate No. 2 amount of \$40,140.

2. That the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said contract.
