RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD IN SUPPORT OF NEW JERSEY DEPARTMENT OF TRANSPORTATION REQUEST FOR THE ESTABLISHMENT OF BUS STOPS WITHIN THE TOWNSHIP OF WEST DEPTFORD

WHEREAS, the New Jersey Department of Transportation ("NJDOT") has conducted a survey to inventory all bus stops in the Township of West Deptford; and

WHEREAS, NJDOT, by letter dated July 10, 2018, has recommended the location of bus stops and/or existing bus stops; and

WHEREAS, the Township Committee supports the recommendations made by NJDOT; and

WHEREAS, in order to legally establish the recommended and/or existing bus stops, a Resolution of Support from the Township needs to be adopted and forwarded to the New Jersey Department of Transportation.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that the Township Committee does hereby support the establishment of the following bus stops within the Township of West Deptford:

BUS STOPS

1. Along Route NJ 45, southbound, on the westerly side at:
 - A. Colonial Avenue – (far side) (NJ Transit ID #20082)
Beginning at the southerly curb line of Colonial Avenue and extending 100 feet southerly therefrom.
 - B. Elberne Avenue – (far side)(NJ Transit ID #20083)
Beginning at the southerly curb line of Elberne Avenue and extending 100 feet southerly therefrom.
 - C. Greenwood Avenue – (near side)(NJ Transit ID #20084)
Beginning at the northerly curb line of Greenwood Avenue and extending 105 feet northerly therefrom.


- D. Budd Boulevard – (far side)(NJ Transit ID #20085)
Beginning at the southerly curb line of Budd Boulevard and extending 100 feet southerly therefrom.
- E. Griscom Lane – (near side)(NJ Transit #20086)
Beginning at the northerly curb line of Griscom Lane and extending 105 feet northerly therefrom.
- F. Riviera Drive – (near side)(NJ Transit ID #20087)
Beginning at the northerly curb line of Riviera Drive and extending 105 feet northerly therefrom.
- G. Parkville Station Road (CR 656) – (far side)(NJ Transit ID #20088)
Beginning at the southerly curb line of Parkville Station Road and extending 100 feet southerly therefrom.
- H. Ogden Road (CR 648) – (near side)(NJ Transit ID #20089)
Beginning at the northerly curb line of Ogden Road and extending 105 feet northerly therefrom.
- I. Third Avenue – (near side)(NJ Transit ID #20090)
Beginning at the northerly curb line of Third Avenue and extending 105 feet northerly therefrom.
- J. First Avenue – (near side)(NJ Transit ID #20091)
Beginning at the northerly curb line of First Avenue and extending 105 feet northerly therefrom.

2. Repealer Clause:

The Township of West Deptford concurs that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this resolution be rescinded upon approval of the Traffic Regulation Order.


