RESOLUTION 2018 - 200

RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD REJECTING ALL BIDS RECEIVED ON JULY 12, 2018 FOR THE HARKER AVENUE AND 2 BISCAYNE BLVD. SLIP-LINING OF CORRUGATED METAL STORM WATER PIPING PROJECT AND AUTHORIZING NEGOTIATIONS BY THE TOWNSHIP ENGINEER

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for slip-lining of corrugated metal storm water piping on Harker Avenue and 2 Biscayne Blvd.; and

WHEREAS, the Township advertised for the slip-lining of corrugated metal storm water piping on Harker Avenue and 2 Biscayne Blvd located in the Township; and

WHEREAS, three sealed bids for the slip-lining of corrugated metal storm water piping on Harker Avenue and 2 Biscayne Blvd. were received and opened on July 12, 2018 from as follows:

CONTRACTOR	BASE BID – HARKER AVENUE	ALTERNATE BID – BISCAYNE BLVD
Compass Construction	\$80,350	\$103,670
Crown Pipeline Inc	\$159,565	\$133,380
NuPump Corp.	\$197,930	\$149,520

WHEREAS, a review of the bids by the Township's Engineer determined that the bids received exceeded the Engineer's cost estimate and the Township of West Deptford's appropriation for the contract pursuant to N.J.S.A. 40A:11-13.2(a) and (b); and

WHEREAS, pursuant to the July 13, 2018 letter from the Township's Engineer, T&M Associates attached hereto, it is recommended that the bids received and opened on July 12, 2018 be rejected for the reasons stated above and that the Township Engineer be authorized to enter into negotiations pursuant to Local Public Contract Law.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township

of West Deptford, County of Gloucester and State of New Jersey as follows:

1. That the bids received from Compass Construction, Crown Pipeline Inc and NuPump Corp and opened on July 12, 2018 for the slip-lining of corrugated metal storm water piping on Harker Avenue and 2 Biscayne Blvd. are hereby rejected for the reasons above stated.
2. That the Township Engineer is hereby authorized to enter into negotiations regarding the Harker Avenue and 2 Biscayne Blvd. slip-lining of corrugated metal storm water piping project pursuant to Local Public Contract Law.




