**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT FOR PROFESSIONAL SERVICES FOR CONTRACT ADMINISTRATION AND INSPECTION SERVICES FOR THE REPLACEMENT OF SANITARY SEWER PUMP STATIONS 4 AND 6 (T&M ASSOCIATES, INC.)**

**WHEREAS**, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for professional services for contract administration and inspection services for the replacement of sanitary sewer Pump Stations 4 and 6 in the Township; and

**WHEREAS**, the project requires a firm to provide said services; and

**WHEREAS**, the Township's Request for Proposal for the position of West Deptford Township Engineer specifically identified the replacement of Pump Stations 4 and 6 as a project to be implemented in 2018; and

**WHEREAS**, T&M Associates, Inc. was appointed as the Township Engineer for 2018 through a Fair and Open Process in January of 2018; and

**WHEREAS**, T&M Associates, Inc. has provided the attached proposal to the Township for professional services for contract administration and inspection services for the replacement of sanitary sewer Pump Stations 4 and 6 dated August 8, 2018, in the amount not to exceed \$122,000; and

**WHEREAS**, the Township has selected T&M Associates, Inc. to provide professional services for contract administration and inspection services for the replacement of sanitary sewer Pump Stations 4 and 6; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township

of West Deptford, County of Gloucester and State of New Jersey on this 15th day of August, 2018, that a contract be and is hereby awarded to T&M Associates, Inc. for professional services for contract administration and inspection services for the replacement of sanitary sewer Pump Stations 4 and 6 for a total contract amount not to exceed \$122,000, subject to all terms and conditions contained in the proposal dated August 8, 2018 and attached hereto.

**BE IT FURTHER RESOLVED** that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said contract.

**ADOPTED** at the meeting of the Township Committee of the Township of West Deptford held on August 15, 2018.
