RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AWARDING A CONTRACT FOR THE RECONSTRUCTION OF LANCING ROAD, LANCING COURT, OAKLAND ROAD AND CHETWOOD COURT (GERALD A. BARRETT, LLC)

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") has a need to award a contract for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court; and

WHEREAS, the Township advertised for public bids for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court; and

WHEREAS, sealed bids for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court were received and opened on August 7, 2018 as follows:

WHEREAS, Gerald A. Barrett, LLC has submitted the lowest complete and responsive bid proposal for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court in the amount not to exceed \$510,202.53; and

WHEREAS, T&M Associates has provided the attached Letter of Recommendation for Contract Award to the Township dated August 8, 2018 recommending that the Township award the contract for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court to Gerald A. Barrett, LLC in the amount not to exceed \$510,202.53; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Township of West Deptford certifying that sufficient funds have been appropriated and are


available to cover this contract and the original of said Certification is attached to the original of this Resolution and shall be kept on file at the Township office.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 15th day of August, 2018, that a contract be and is hereby awarded to Gerald A. Barrett, LLC for the reconstruction of Lancing Road, Lancing Court, Oakland Road and Chetwood Court for a total contract amount not to exceed \$510,202.53, subject to all terms and conditions contained in the bid package.

BE IT FURTHER RESOLVED that the Mayor and/or Township Administrator are herein authorized to execute all appropriate contracts, documents and agreements respecting the award of said bid.




