RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD AUTHORIZING CHANGE ORDER NO. 1 TO D.A. NOLT, INC. FOR REPLACEMENT OF WEST DEPTFORD TOWNSHIP MUNICIPAL BUILDING ROOF

WHEREAS, the Township of West Deptford (hereinafter referred to as "Township") awarded a contract for the replacement of the West Deptford Township Municipal Building Roof (hereinafter referred to as the "Project") to D.A. Nolt, Inc., pursuant to Resolution #2017-345 adopted on December 20, 2017, in the total contract amount of \$336,990; and

WHEREAS, it has been determined that a Change Order No. 1 to the original contract is required to address as-built quantities and the deck allowance (Item No. 10) which was not fully utilized, resulting in a credit to the contract; and

WHEREAS, D.A. Nolt, Inc. has submitted a proposal dated August 9, 2018 outlining the credit for the as-built quantities and deck allowance in the total amount of \$14,594.88; and

WHEREAS, T&M Associates has submitted a letter dated August 14, 2018 outlining the credit for the above and recommending the approval of Change Order No. 1 in the total amount of \$14,594.88 for a revised total contract amount of \$322,395.12.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 5th day of September, 2018 that the Township of West Deptford does hereby authorize Change Order No. 1 to the contract with D.A. Nolt, Inc. for the replacement of the West Deptford Township Municipal Building roof, resulting in a credit to the Township in the total amount of \$14,594.88, for a revised contract amount of \$322,395.12.




